Conditions:-

1. Amount of Post Matric Scholarship is to be paid to SC students admitted through central counseling of HSCS as well as institution Level having parent income less than 1.00 lacs. No amount of Post Matric Scholarship is to be paid to SC students having parent income above 1.00 lac.
2. All the institutions have to ensure that Tuition fee/Dev. Fund/student fund components per annum as fixed by SFC for self financing Instt., By state Govt. for Govt. Instts./Aid-ed Instts. is to be reimbursed and exam fee as fixed by competent authority).
3. The SC student must have made an application in the prescribed format to the institution concerned. The application is to be countersigned by head of Institute certifying the information filled in. This application is to be submitted to the institution releasing payment and not to this office.
4. The students must have been admitted in batch of session 2009-10 and studying in current session 2009-10 and also the SC students of Haryana with parent income less than 1.00 lac admitted through Central Counseling of HSCS as well as Institution Level Counseling during session 2007-08 and 2008-09 are eligible for fee reimbursement for the current session i.e. 2009-10
5. Students seeking this reimbursement have not claimed the reimbursement from any other Government/Government funded Department/Agency.
6. At the time of reimbursement students continuous to be enrolled with the Institution and has been promoted to next class.
7. UC is to be submitted by the Principal of concerned Government Polytechnic who has been authorized to make payment by this office. Principal of concerned Government Polytechnic shall maintain a consolidated

record in a separate register regarding disbursement/reimbursement of the tuition fee under the scheme with the appended signatures of the claimants from respective head of the Institutions.

8. The Principal of Govt. Poly authorized to release payment will ensure that cheque of payment is handed-over directly to the said students. However, in case the institutes gives an undertaking that no fee charge from SC students and same shall be released in favour of that institution.
9. All other conditions as explicitly mentioned in the schemes
10. It is specifically mentioned that the responsibility for authentication/ verification of submitted data/documents/fulfillment of guidelines lies with the head of Institution where student is admitted.
11. The institutions have to supply the SC students list and certificate of 80% attendance of the SC students availing Post Matric Scholarship to be sent to the concerned Disbursing Institute on quarterly basis.
12. The institutions have to get open the accounts in the name of concerned SC students in the nearby Post Office/bank for reimbursement of fee directly to the account of the students.
13. 25% of payment shall be released in the first goes in the balance in three equitable installments in current and subsequent semester.
