Sub:- Regarding promoting cashless transactions - action taken.

Sir/Madam,

Kindly refer to communication bearing No. 28/71/2016-4B&C dated 23.11.2016 on the subject cited above. It is hoped that action might have been initiated for receiving payments by the Government Departments like Utility Bills of various Govt. Departments viz UHBVNL, DHBVNL, HUDA, PHED, Tickets of Haryana Roadways, Fees of Schools/Colleges, purchase of seeds/fertilizers, Tourist Complexes of Haryana Tourism Department, etc. through Debit/Credit Cards specially the Rupay Card/e-wallet of different Companies etc. If same has not been done, it must be ensured that the Swipe Machines are installed or the e-wallet are loaded on the Mobiles of the persons posted at the Cash Counters by taking adequate safeguards by 30.11.2016 positively. Government of Haryana aims to achieve the target of moving towards complete cashless transactions before the end of December, 2016. Hon'ble Finance Minister, Haryana will be reviewing action taken in this regard with the concerned Administrative Secretaries at 12.00 Noon on 05.12.2016 for which a separate notice is being issued. Administrative Secretaries are requested to ensure requisite necessary action in organizations under their administrative control for enabling public to make cashless payments in respect of all the transactions with Govt. of Haryana on priority.


