Initially the affiliation shall be on annual basis and there after based on the yearly performance of the Polytechnic it may be considered for permanent affiliation.

Provisional affiliation has been accorded subject to the fulfillment of minimum norms and standards of the HSBTE for the sanctioned courses and intake as approved by the competent authority. The Polytechnic/ Institute has deposited affiliation fee i.e. Institutional affiliation fees is Rs. 50000/- per year and course affiliation fees @ Rs. 30000/- per course per 60 intake along with the affiliation Performa.

The Polytechnic/Institute is bound to make admissions through Haryana State Counseling Society only or as per policy of Department of Technical Education and no excess admissions shall be made. The Polytechnic/Institution shall strictly adhere to the policy framework of DTE/HSBTE/AICTE from time to time. The Polytechnic shall adhere to all the norms as specified for faculty qualifications and pay scales, cadre ratio, student-teacher ratio, infrastructure facilities, laboratory, workshops, machinery, equipments, computer facilities, library facilities and other facilities. BOG of the Polytechnic shall ensure that admissions are made in a fare & transparent manner and the utilization of the institutional resources including student fund is for welfare of students.

In the event of infringement/ contravention of non-compliance of the HSBTE affiliation norms and / or the provisions as specified by the State Government/ norms and standards as prescribed by AICTE/PCI, poor academic performance such as poor results, poor teaching-learning process, non completion of prescribed courses/no. of teaching hours or any non- ethical academic activity, capitation/ charging of higher fee action leading to Reduced Intake, No Admissions or Category Withdrawal of Affiliation or any other action as decided, may be taken by HSBTE and the liability arising out of such actions shall be solely of the management of the your Polytechnic/ Institution.
