**ORDER**

The State Fee Committee has decided that all the colleges affiliated to Kurukshetra University, Kurukshetra shall make the payment for N.S.S. fee out of the student fund collected by them.

2. Each self financing institution was impressed upon to adopt some Govt./ Aided High / Senior Secondary Schools for mentoring the students to attract them towards technical education and these institutes agreed in principle.

3. Every institute shall submit a scheme of scholarship/free ship within one week to the department so that the same can be compiled and put on the departmental website as well as on the institute web site. Atleast 10% of the students should be covered by scholarships/freeships.

4. To encourage girl students, the colleges shall adopt the incentive by floating various scholarships and other schemes for every girl student.
