Subject: - Disaffiliation/ Withdrawal of approval in respect of Shree Ram Mulakh College of Technical Education, Khura- Bhura, Naraingarh, Ambala - Show Cause Notice.

It is informed that the expert committee conducted inspection of your institute on 8.3.08. On the perusal of inspection report of expert committee & further examination of the documents concerning your Society for establishment of Engg. College namely Shree Ram Mulakh Institute of Engg. & Technology, Khura Bhura, Naraingarh, Ambala, Polytechnic namely Shree Ram Mulakh College of Technical Education, Khura- Bhura, Naraingarh, Ambala & MBA Institution namely Shree Ram Mulakh Institute of Management & Technology, Khura- Bhura, Naraingarh, Ambala, it has been found that same plot of land measuring 88 kanal (11 acre) in the name of society through registered gift/ sale deed has been used for setting up of these 3 institutions. Whereas as per AICTE norms, 16 acre minimum land is required in the name of society through registered gift/ sale deed for setting up these 3 institutions (10 acre land for Engg. College, 5 acre for polytechnic & 1 acre for MBA). You /your representative misinformed to the Scrutiny Committee, which examined documents for establishment of your polytechnic namely, Shree Ram Mulakh College of Technical Education, Khura- Bhura, Naraingarh, Ambala on 17.8.2007, by showing the same land papers meant for Engg. College & also to the Inspection Committee on dated 8.10.2007 and further by showing the same building and other infrastructure of Engg. College for Polytechnic. The use of the same land, building and other infrastructure for Engg. College as well as for Polytechnic by your society is gross violation of AICTE norms. To pass off the same plot of land for setting up 3 different institutions in connivance/ negligence with the members of the original Scrutiny Committee & Inspection Committee is a clear case of cheating & fraud.

In view of this, it has been decided by the State Govt. /State Level Committee to disaffiliate your institute from SBTE, reallocate existing students & further recommend to AICTE for withdrawal of approval w.e.f. the Academic Session 2008-09. To this effect, you are hereby issued a Show Cause Notice, which shall be replied with in a period of 15 days from the issue of this letter (i.e upto 11th June,2008). In the event of no reply or the reply not found satisfactory, action shall be initiated against your institute leading to disaffiliation from SBTE, reallocation of existing students & withdrawal of approval and other appropriate action as deemed fit. The liability arising out of such action will be the sole responsibility of management of the institution.
